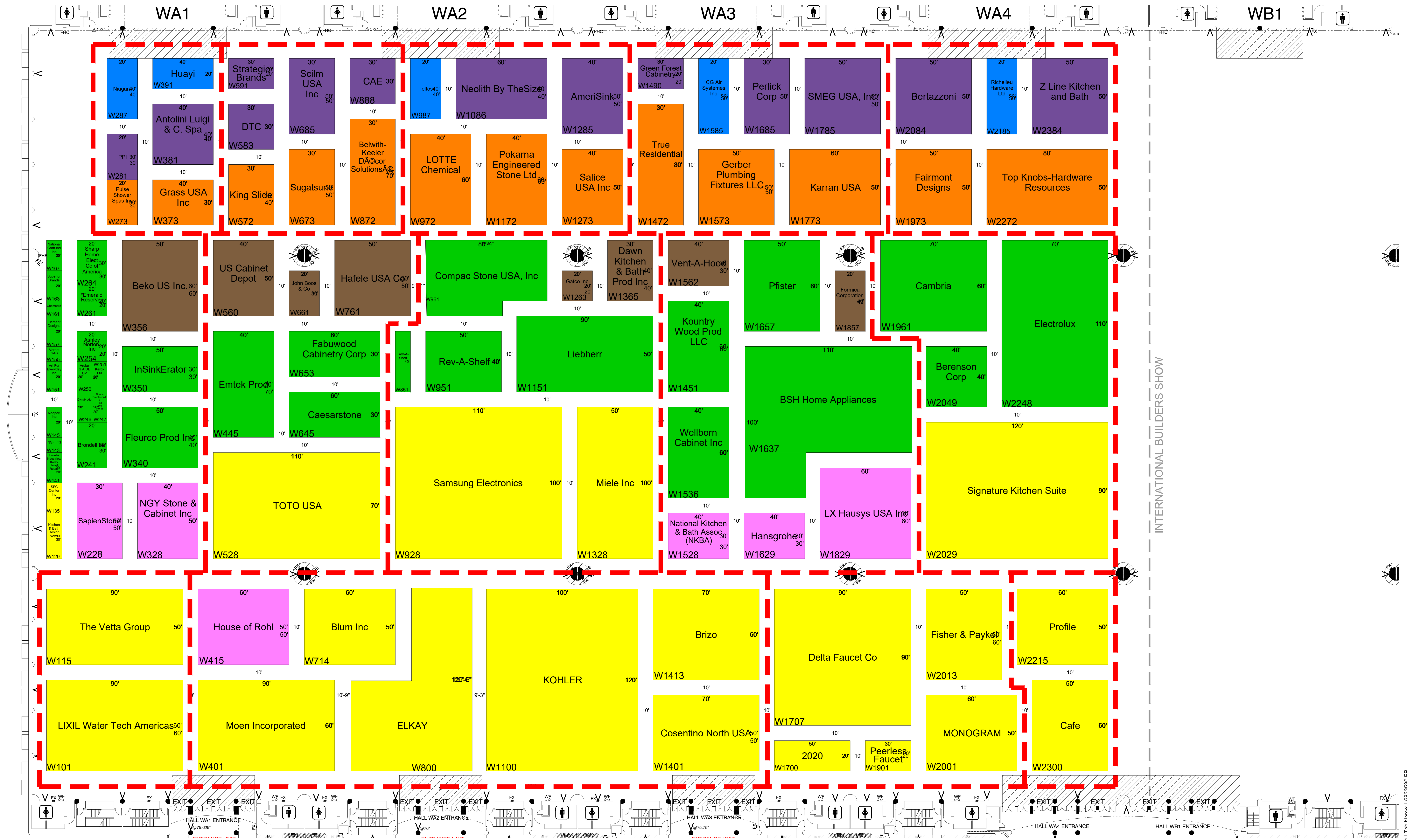

- In order to ensure a safe and smooth move-in, target dates and times will be strictly enforced for shipments delivered directly to the show.
- Delivery drivers should start the check-in process, at the marshaling yard, two hours prior to assigned target time.
- Deliveries arriving two hours after their assigned time will be dispatched last for the assigned target time and could impede your set up.
- Deliveries arriving five hours after their assigned time will be considered late and will be unloaded after all other deliveries have been dispatched and could impede your set up and incur additional material handling charges.
- Direct deliveries will be unloaded at the discretion of Freeman and will be dispatched according to target date/time and are guaranteed to be delivered to your booth by the end of the assigned target day.
- Exhibitors are not required to be present for the delivery of your freight.
