OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. ELIGIBILITY; METHOD TO ENTER; SUBMISSION GUIDELINES.

The Campaign is only open to legal residents of the continental U.S. and Canada, who are in the age of majority for their region at the time of participation, and is void where prohibited by law. Employees of KBIS, Emerald, and advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members are not eligible to participate in the Campaign. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of KBIS. Exhibitors in each category (listed below) who register the most attendees with their codes will be eligible to win \$2500 to use towards their KBIS 2024 booth space.

4. DESCRIPTION AND VALUE OF THE PRIZE; ODDS OF WINNING.

The Winner(s) of the Campaign (the “Winner”) for each category (100-600 sq.ft, 601-1200 sq.ft, 1201+ sq.ft) will receive a prize toward KBIS 2024 as follows: One exhibitor in each category listed above who registers the most attendees will be eligible to win \$2500 to use towards their KBIS 2024 booth space. No cash or other prize substitution shall be permitted except at KBIS’s discretion. The prize is non-transferable. Acceptance of prize constitutes

Winner will be notified by email within five (5) days following selection of Winner.
